

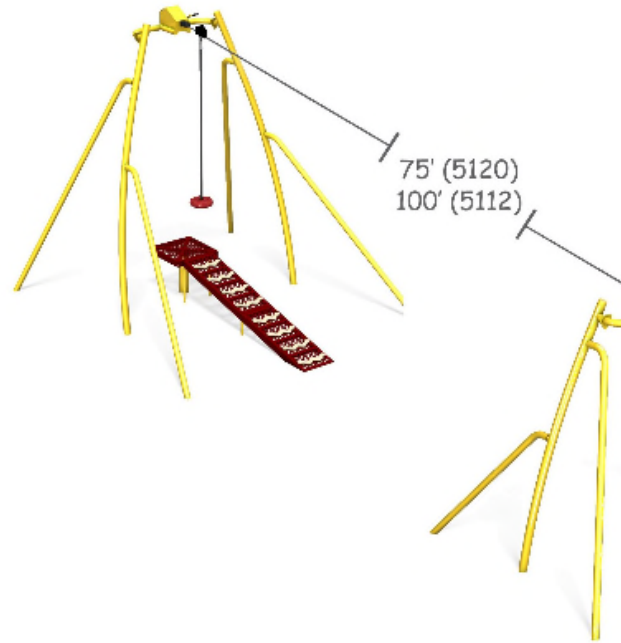

6. Proposed New Tax Incremental Districts 14 and 15

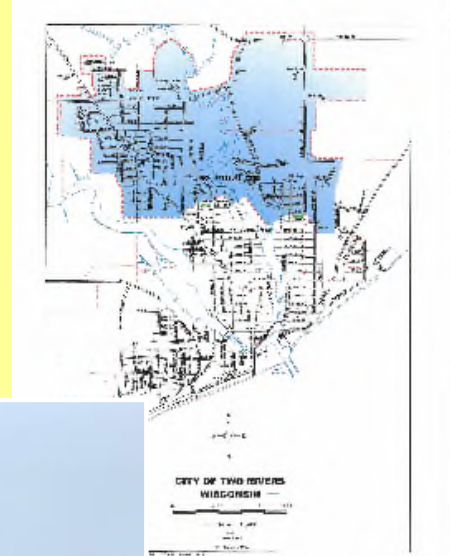
