A. MOW Changes

As of March 1, 2017, Corporate Aurora will no longer be providing diabetic and special meals for the Meals On Wheels routes. There is a need for the MOW program. To keep the program going, the senior center kitchen will provide the diabetic and low-salt meals. Sandwiches were served as the "supper meal". This will be replaced with frozen dinners prepared by the senior center kitchen. Tuesday and Thursday's will be added to the Mishicot route, with their volunteers pick up the meals and delivering them. The Sunday meal delivery will discontinue. This meal will be a frozen dinner delivered with Saturdays meal.

B. Anhalt Nature Area

Permission was given to remove some of the dead trees in the nature area to allow for new growth.

C. Vietnam Parking

Vinton Construction purchased the St Peter the Fisherman School. The city was allowed access to the parking area for events from previous owners. Access to the parking area will continue through 2017. In order for Vinton to enhance the property and conduct business, the existing parking lot will be for Vinton only and not for public access. The City will receive a small portion of the existing parking lot, but will need to develop/add additional parking to accommodate diamond usage.

D. Terrific Tuesdays - February

New program designed for families to spend time together. A designated time is set for gym usage for families to play kickball, softball, basketball, soccer, or other sport together.
