D. Projects for 2019

Erin requested the 2019 projects be presented to inform the board of the projects that are approved in the new budget.

- * \$30,000 Installation of automated pay kiosks at the Vets Park Boat Launch and the Harbor Park docking area. Aided by \$15,000 in grants.
- * \$60,000 for public restrooms and additional renovation at the old Riverfront Liquor building for trail users.
- * \$120,000 for a new, quarter-mile bike and pedestrian trail connection from Mariners Trail to the South Pier. Aided by \$78,000 in grants.

- * \$50,000 for the next phase of ball field lighting replacement at Vietnam Vets Park purple diamond. Capital campaign to seek grants and donations to assist with this project. Possible removal of lighting at Neshotah diamond.
- * \$20,000 for security cameras at the Community House and various locations.
- * \$5,000 for restructuring the building, moving the recreation offices, and turning the racquetball court into a dance/yoga studio to make it a more utilized space.
- * \$15,000 to remove the deteriorated tennis courts at LB Clarke and convert to playground space.

Additional funds are earmarked for maintenance equipment, playground equipment replacement, park improvements, and athletic field renovations.
