Presentation by Two Rivers Family Swim Center

Mark Ducat, Shannon Zarn, Theresa Collins and Stephanie Jeske presented information on the history of the Family Swim Center and plans for a major renovation project at the facility. They noted that the center has 103 current members including family and single memberships.

The Family Swim Center representatives asked that the City consider funding \$14,820, or half of the cost of a \$29,640 Resource Development and Capital Campaign to be contracted with Beacon Organizational Consulting.

Mr. Buckley suggested that the City Council could consider this request during the 2019 Budget process. He noted that assistance to this community not-for-profit for this project might be an appropriate use for funds currently in the City's CDBG-funded Economic Development Revolving Loan Fund, if those funds are "de-federalized," as is being recommended by the State of Wisconsin.

6. Final Review of Listing of Priority Redevelopment Sites

Mr. Buckley reported on the list, noting locations of interest to the City and sites that should be promoted for private investment. He added that he would like to promote on the City's website the sites that are open for development. Following discussion, Mr. Buckley stated that he would make modifications to the list and return it for action at a future City Council meeting.

7. Discuss Citizen Concerns Regarding Vietnam Veterans Park

Mr. Buckley reported on the new contract for concessions at Neshotah Beach and Vietnam Veterans Park. He noted that Council members Gonnerman and Powalisz have indicated that they would be willing to meet with the City Manager, the Parks and Recreation Director and Adam Wachowski to discuss any concerns about Vietnam Veterans Park.
