WALKING (AND DRIVING) IN A WINTER WONDERLAND --Ordinances on Snow and Ice Removal

Per Municipal Code 4-1-6, snow and ice shall be removed from any public sidewalk within 24 hours from the time when the snow ceases to fall. For corner lots, this includes the sidewalk and any ramps.

If such snow or ice is not removed timely, the City may cause such to be removed. The City shall bill the cost of such removal to the property owner. For the second and any subsequent violations of this section within any November 1 through April 30 period, the property owner may be subject to a fine of \$150 plus court costs in addition to any billing for snow and ice removal by the City.

Per Municipal Code 4-1-12, blowing or depositing snow or ice in the street is a traffic hazard and is prohibited. Offenders are subject to fines.


