### GETTING THE LEAD OUT: UPDATE

While activity is paused due to winter weather, the City continues to make substantial progress in replacing lead service laterals (lsl's) in the water system.

Coming into 2024, there were about 1,800 lsl's in the system, out of 5,100 total water services.

A \$3.9 million contract awarded in 2024 addresses about 300 service replacements at locations in the central part of the city. This work started in 2024 and will continue in 2025. Another 50 services were replaced in 2024 as part of the Roosevelt Avenue reconstruction.

Another contract will be awarded in 2025 for replacement of 150 lsl's on the city's eastside, south of 22nd Street.

The City continues to pursue State and Federal funding to assist in this very expensive undertaking. Federal ARPA funds (City and County) were applied to 2023 and 2024 projects. Low-interest loans and grants through Wisconsin's Safe Drinking Water Fund are an ongoing source of funds for these efforts, including the 2025 projects.



In 2025, the City will continue to provide funding of \$2,500 per property to help with the cost of the "private side" portion of the lsl's (from the shutoff valve near the street to the property's water meter).

In many cases, this funding covers the full cost of the private side lsl replacement. The "public side" replacement (shutoff valve to water main), covered by the Water Utility, is more expensive because it also involves tearing up and then repairing the street.

The federal government (US EPA) recently finalized a long-expected rule that requires replacement of all lead in municipal water systems within the next decade. That is a worthy goal, but one that will require an enormous amount of local, state, federal and customer funding to achieve over the next 10 years.

Through the leadership of the Parks and Recreation Department, public trees along streets, in parks and on public properties are getting some overdue attention. Partnerships with several funding sources and community groups will expand those efforts in 2025.

For the third year in a row, the City has been awarded a WI DNR URBAN FORESTRY grant, for \$25,000. Previous years' grants have funded a

inventory, staff training and some tree planting. This year's grant will fund a Youth Apprentice in forestry and assist in removing dead and dangerous trees, planting replacement trees, and undertaking educational programming with our local schools.

The LAKE MICHIGAN BIRD OBSERVATORY (LMBO) Partnership received a grant from the DAYBREAK FUND to support community forestry efforts along the Lake Michigan shore.

#### INVESTING IN OUR URBAN FOREST (cont'd)

LMBO will be providing the City with 60 trees to be planted in terraces on the southside. City staff will also participate in training related to the creation and use of bio-char, a substrate made from burned organic matter that can support the health of trees when used during planting.

GRACE CONGREGATIONAL CHURCH and the City have been awarded a \$15,000 grant from an organization called FAITH IN PLACE This grant will fund a forestry track Youth Apprentice for 450 hours, planting of 20 trees at Washington Park, and costs associated with tree care and administration. Washington Park has had close to 20 dead trees removed in the last year.

A portion of the ENVIRONMENTAL FEE on utility bills is used each year to support care for trees in parks and streets. This year the City will continue to remove dead and dangerous trees along streets that were designated in a tree inventory completed in 2023. Funding from this source will allow planting of 30 to 40 trees throughout the city, to replace those that have been removed in recent years.
