6. Committee Reports

a. County Aging Unit - Wendy Hutterer

Medicare Part D open enrollment appointments available through December 7. The 2022-2024 Aging Unit Plan draft is available for review on the ADRC of the Lakeshore website. Meal sites are open. Attendance numbers are low across the state as they were before covid, but the numbers are climbing. 60 yr. old people have more activity and dining options now than in years past.

b. City Council - Bill LeClair

Two Rivers will be reducing the polling locations from 4 to 2. Wards 1-5, St Peter the Fisherman and Wards 6-8, Abundant Life Church. The change will reduce costs and streamline the process before, during and after Election Day. Possible changes to rules on the speed and use of bicycles and other motorized transportation on the sidewalks downtown & by the beach. Sandy Bay Highlands lots continue to sell. Police Departments K9 fundraising goal has been met. New officer has been hired for the K9 unit. Leaf pick up will continue through November. 365 West Central Park fundraising. The committee will meet next Thursday, November 11. Veterans Day Ceremony in Central Park at 11am with breakfast and program to follow at the Two Rivers High School on November 11. Two Rivers Main Street Trivia Contest. November 12.

c. Recreation Department Programs - Terri Vosters

Maintenance is winterizing park bathrooms and docks. Recreation staff are planning spring activities in preparation of the next program book. Flag football has finished for the season, 60 players participated this year. The Community House front step restoration was completed with added nonslip surfacing. Budget 2022 is being reviewed for City Council approval. Researching grant opportunities for Neshotah Park Phase Two and pickleball & tennis courts. Discussion on vandalism in park bathroom and costs associated with these unfortunate events.

d. Senior Center - Tammy Desten

Senior Health & Information Fair had 39 vendors with 250 people in attendance, raised \$3,428. The Trust car needed new front & back brakes and the Senior Center van needed heat braker/blowers replaced; all repairs completed at Sauve's Auto. 12 people attended the Halloween Costume and movie party. Spirit of the Shoreline Day bus trip went well. There are only 5 seats remaining on the December Christmas Stars trip. November 11 & 12, Rummage Sale. December 9 & 10 Christmas cookie sale and basket raffle.
