C. Review draft ordinance regulating storage canopies

Discussion included increasing the permit fee from \$10 to \$50 based on the amount of time expended to process and inspect each canopy. The proposed permit fee increase would be equal to the minimum permit fee for detached accessory buildings.

Further discussion included establishing an end date when permits will no longer be issued for canopies. Canopies, erected by permit, prior to the end date may remain until they need to be repaired or replaced.

Motion to recommend approval to modify the permit fee for canopies (erected after the ordinance date) to \$50 and establish January 1, 2023 as the end date when permits will no longer be issued for canopies. Upon a roll call vote, motion carried.
