Room Tax Commission Thursday, May 20, 2021 10:00 AM Council Chambers, City Hall

#### 1. Call to Order

The meeting was called to order by Commission member Mark Bittner at 10:02 AM.

#### 2. Roll Call

Committee Members present: Curt Andrews, Mark Bittner, Greg Buckley, Bill LeClair and Jim VanLanen, Jr.

## 3. Status of 2021 Tourism Marketing Activities

Curt Andrews reported that the Branding and Marketing Committee had met the evening prior to this meeting, and that the committee's work is focused on promotion of Summer 2021 activities. He added that \$1,5000 in donations have been received for the second annual Celebrate Two Rivers.

Greg Buckley noted the room tax revenues through April totaled just over \$34,000; this compares with just over \$19,000 at this time last year. He stated that, in addition to the positive impact of adding a new hotel, there are significant room tax revenues attributable to vacation rentals. He added that the reports from booking services like AirBnB lack detail as to which properties the room taxes are attributable to.

Mark Bittner volunteered to look further into the reporting practices of booking entities like AirBnB.

4. Consider Authorizing Contract with Vision Architecture for Design Services Relative to Possible Re-Use of Water Department High Lift Building for Welcome Center and Trailhead Facility

It was the consensus of commission members to defer this matter to a later agenda.

## 5. Closed Executive Session

At 10:12 AM, Bill LeClair moved, supported by Curt Andrews, to enter into closed session per Wisc. Stats. Section19.85(1)(e), deliberating or negotiating the purchasing of public properties, the investing of public fund, or conducting other specified public business, whenever competitive or bargaining reasons require a closed session.

# **Action in Follow-Up to Closed Session Discussions**

Curt Andrews moved, supported by Bill LeClair, to authorize City Manager Buckley to sign a joint letter with Manitowoc Mayor Nickels, notifying the Manitowoc Area Convention and Visitor Bureau of the intent of the room tax commissions of the two cities to not renew the current Tourism Services Agreement; provided further that if there is not a joint letter, then Two Rivers shall sent its own letter to the MAVCB and to the Manitowoc Room Tax Commission, informing them of Two Rivers' intent not to renew the agreement.

It was noted that such notice must be provided before June 1, or the current Tourism Services Agreement automatically renews for a three-year term.
