# Two Rivers Senior Center Code of Conduct

The City of Two Rivers Senior Center is committed to providing a safe and welcoming atmosphere for our patrons, volunteers, guests, and staff. Therefore, everyone who visits the Two Rivers Senior Center is expected to adhere to a code of conduct when taking advantage of the center's services, programs, and facilities. Acts of violence, disrespect of patrons, volunteers, or staff, misuse or abuse of the facility or senior center equipment, and use of foul language or gestures will not be tolerated.

To ensure a comfortable and safe environment for all who visit our center, we reserve the right to remove patrons engaging in behavior that is potentially harmful to themselves or others from facilities, programs, or services as determined by the Senior Center Supervisor.

Unacceptable behaviors include but are not limited to:

- The use of profane, abusive, obscene, insulting, or sexually aggressive language with intentions including but not limited to bullying, hate speech, threats, and harassment.
- Threatening physical violence or an act of physical violence.
- Violating any federal, state, county, or city laws.
- Misusing, damaging, or stealing Senior Center equipment, resources, or facilities.
- Failing to maintain a basic level of personal hygiene.

Anyone violating the code of conduct is subject to the following consequences at the discretion of the Senior Center Supervisor:

1. A verbal warning, and a refresher on the expectations laid out by the code of conduct.
2. Suspension from the Senior Center for a period TBD by the supervisor.
3. A permanent ban from the Two Rivers Senior Center.
