## Industrial Power (Cp-3) – over 1,000KW

Customers on this rate who are meter on the primary side receive a discount. A discount is also available to customers who own and maintain their own transformer/substation equipment

Residential customers will be billed for sewer charges for their actual water usage during November through March and the monthly average from April through October. Industrial customers with excessive strength wastewater shall be charged an additional monthly charge.

**COMMITMENT TO  
COMMUNITY CHARGE**  
EFFECTIVE 5/1/2020

**Commitment to Community programs promote energy conservation & help qualifying households afford the energy they need.** All electric utilities in the State of Wisconsin are required to collect this type of fee.

**Rate Class**

Residential	<b>Rg-1 &amp; Rg-2: accounts</b> 3.0% of the total electrical bill not to exceed \$1.36.
General Service	<b>Gs-1 &amp; Gs-2 accounts:</b> 3.0% of the total electrical bill not to exceed \$2.50.
Small Power	<b>Cp-1 accounts:</b> 3.0% of the total electrical bill not to exceed \$7.50.
Large Power	<b>Cp-2 accounts:</b> 3.0% of the total electrical bill not to exceed \$35.00
Industrial Power	<b>Cp-3 accounts:</b> 3.0% of the total electrical bill not to exceed \$50.00.
Lighting Services	<b>Ms-1 &amp; Ms-2:</b> No Charge.

**Non-Standard Meter Service Charge–** Effective 1/1/2018 Residential customers who choose not to have standard meter service on their premises will be charged a Non-Standard Meter Reading Charge of \$10.00 per month.

**Renewable Energy Rates**

<i>Effective 8/1/2021</i> All rate classes (Rg-1, Rg-2, Gs-1, Gs-2, Cp-1, Cp-2, Cp-3, Ms-1 and Mp-2)	\$2.00 per 300 kWh block of renewable energy per month purchase one or more blocks. The additional charge appears as a separate line item on your monthly bill. For large business customer opting to purchase 100 or more blocks, discounted rate is \$2.00 per block per month

**Environmental Fee**

<i>Effective 8/1/2021</i> Residential Customers	In addition to the \$2.50 sticker that is needed on each 30-gallon container of garbage collected by the City's contracted service, a \$7.00 monthly fee will be charged on your utility bill.
